11/102B Approval of the Minutes of the Environment and Planning Committee Meeting held on 9<sup>th</sup> January 2012

It was resolved to approve the minutes.

#### 11/103B Matters Arising from the Minutes

11/103.1B (Item 11/88.1B) <u>Safe Route to Schools</u> It was **resolved** to note that no reply had been received from the landowner despite being chased.

(Item 11/88.2B) <u>Empty Homes</u> It was **resolved** to note the response from the Building Control Officer regarding Corner Cottage and to keep an eye on the situation. It was further **resolved** to note the reply from Nick Jobson who agreed to give further details of priorities but nothing had been received and the Clerk was asked to write to Ian Timms of the District Council to request pressure put on resolving the empty properties and in particular the houses next to the Police Station and the thatched cottage next to the Free Press office.

11/103.3B (Item 11/88.3B) <u>Union Lane</u> It was reported that some vegetation had been cut back and some of the litter cleared away but more litter was being deposited. It was **resolved** to keep an eye on the situation.

11/103.4B (Item 11/88.4B) <u>Williton Signage</u> It was **resolved** to note the reply from the Highways regarding the installation of the signs and to write to Active signs asking them to install the signs on the existing posts after renovating and painting them.

11/103.5B (Item 11/88.5B) Village Clock Two quotations had been received for double faced drum clocks and as both had the same technical specifications it was **resolved** to go ahead with the cheaper quote provided the additional costs were the same. It was further **resolved** to have the wording "Queen's Diamond Jubilee" engraved around the edge of the clock in gold and "2012" on the face of the clock in black. The Clerk would check with an electrician regarding the best location on the Parish Office building. It was further **resolved** that a donation of £500 had been received from Magna Housing to offset some of the costs.

11/103.6B (Item 11/88.6B) <u>Buiulding Community Programme</u> The meeting was preceded by a presentation from Paul Weston regarding Neighbourhood Planning. It was agreed that there was a lot of work involved but it would be important to involve the community and would be a worthwhile exercise in the long term. It was **resolved** to recommend to Full Council to pursue the notion of a Neighbourhood Plan and appoint a working group to invite the community, professional bodies and Sampford Brett Parish Council to work together.

11/103.7B (Item 11/95B) <u>Conservation Area</u> It was **resolved** to note that work was in progress and should be completed in the near future

#### 11/104B Correspondence

11/104.1B It was **resolved** to note the request for a street light between 7 and 9 North Road and to reply stating there was no money in the budget at present and suggest security lighting as a means of resolving the problem.

11/104.2B It was **resolved** to note the Pre-Planning Public Consultation on 15<sup>th</sup> February regarding the proposed housing development at Watery Lane received from Summerfield Homes.

11/104.3B It was **resolved** to note the booklet on Neighbourhood Planning from the Campaign to Protect Rural England which Cllr McDonald agreed to read and circulate within the Committee.

11/104.4B It was **resolved** to note the Forum 21 Public Meeting on 22<sup>nd</sup> February regarding planning policies and the Localism Act.

### 11/105B Highways Matters

It was **resolved** to note the response from the Highways Department and their reluctance to install a box junction due to new Civil Parking Enforcement coming into operation shortly. It was **resolved** to reply requesting that a junction be installed if there was no improvement after monitoring the situation for 3 months after the new enforcement notices were in operation.

A verbal request had been received from a resident in Bridge Street requesting residents' permits for Nos 1,3,5 and 7. As there was no current scheme for residents' permits it was suggested he writes to the District Council to request setting up such a scheme.

Regarding the problems of visibility at the junction of North Croft and Long Street it was **resolved** writing to the owners of Fairfield House requesting that they cut back the hedge.

## 11/106B Finance and Budget Considerations

As no reply had been received regarding the bus shelter it was resolved to take this out of the budget.

#### 11/107B Items of Report from Grounds Maintenance Officers

- 11/107.1 <u>The Copse</u> There was nothing to report
- 11/107.2 <u>Bellamy's Corner</u> It was **resolved** to note the reply from the County Council regarding the responsibility towards the maintenance of the wall and to send copies of their reply to the neighbouring landowners.
- 11/107.3 <u>Doniford Car Park</u> It was noted that the potholes were getting bigger and it was suggested asking the Groundsman to fill them with some hardcore.
- 11/107.4 Recreation Ground There was nothing to report.
