15/94B Matters to Report

(Item 15/79.1B) <u>Pedestrian Routes</u> It was **resolved** to note the original plan which had been circulated. After the meeting that had been held with David Noad, Savills, it was **resolved** to rename this item

Pedestrian Routes / Safe Route to Schools.

(Item 15/79.2B) <u>State of Road at St Peter's Close</u> The Clerk had circulated a document on Claiming Ownerless Land. It was noted the Parish Council had not done anything which would enable them to take adverse possession. It was **resolved** members would consider the document in detail before the next

meeting.

(Item 15/79.3B) <u>Village Information Board and Parish Guide</u> It was noted that the working group had not yet met; however, information and photographs had been collated. It was **resolved** that a meeting would be half to be the left that the problem is the problem.

(Item 15/79.4B) Flooding Matters Cllr McDonald advised that the streams had held up during the recent rainfall, but that surface water had caused a problem in Doniford and Priest Street, due to the sheer capacity of water running off the land. It was noted that the hedge had recently been cut at Priest Street, but the chippings had not been cleared; concern was voiced as this could cause the ditches to become blocked. Cllr Bigwood reported a problem at the leat by the Bakelite Museum. It was **resolved** to invite

the Environment Agency to look at the problem as they had built the leat and were responsible for the maintenance. It was further **resolved** to talk to David Noad from Savills regarding the Sluice Boards.

It was **resolved** the Clerk would obtain quotations to be presented at the next meeting. It was further **resolved** the Clerk would obtain quotations for the re-instatement of rubber matting on the top of the Play tunnel. It was noted from the Trustees of the Williton War Memorial Recreation Ground that the playground inspections would now take place fortnightly.
