Approval of the Minutes of the Environment and Planning Committee Meeting held on 13<sup>th</sup> January 13/106B 2014

It was **resolved** to approve the minutes.

#### 13/107B **Matters to Report**

- 13/107.1B (Item 13/96.1B) Safe Route to Schools It was resolved to note that no further correspondence had been received and the Clerk agreed to chase this again. It was further resolved to change the heading to "Pedestrian Routes" to include other projects.
- (Item 13/96.2B) Empty Buildings It was resolved to note that a letter had been written to Sir Ray Tindle, and 13/107.2B that the Regeneration Forum had shown an interest in the project. Cllr Troman agreed to enlist some public interest. It was further resolved to note the response from the Building Control Officer and that the exterior did not appear to be in a dangerous condition.
- 13/107.3B (Item 13/96.3B) Waste Dumping along Doniford Stream Cllr Koch advised that Cllr May had had been in contact with Alan Bulpin but the present flooding had altered the situation. Cllr McDonald agreed to look at this again when going around the village with Cllr May shortly.

#### 13/108B Correspondence

- It was resolved to note the Consultation on the Pre-Submission Somerset Mineral Plan and that comments 13/108.1B had already been submitted.
- 13/108.2B It was **resolved** to note the copy of the e-petition to amend the National Planning Policy Framework and that members could respond individually.
- It was resolved to note the leaflets for the Somerset Levels Relief Fund and members agreed to circulate in 13/108.3B areas of the village. It was also resolved to put the letter of request for financial support on the next Finance and Administration Committee agenda.

#### 13/109B **Highways Matters**

- 13/109.1B Unauthorised Parking The Clerk agreed to write directly to the Manager of the Co-op regarding reimbursement of parking fees for their customers. There was no further news from the District Council regarding free parking spaces and the Clerk agreed to chase this. She also agreed to write to lan Titcombe to ask when the zig zag lines outside the Post Office were to be extended.
- Other Various Highways issues The Clerk advised that she had received a report of subsidence at Tower 13/109.2B Hill which was being dealt with by the Highways. She was asked to send a copy of the email to Sampford Brett Parish Council as this was on the boundary. She had also received a report of a blocked drain at High Street which was also in hand.

#### 13/110B **Finance and Budget Considerations**

- 13/110.1B Village signs at Doniford It was resolved to note the site meeting to discuss the location of the signs was postponed due to the recent bad weather and would be rearranged shortly. It was resolved to recommend the increase of cost to £582 including posts and installation as there had been a delay in the order.
- 13/110.2B Sale and Disposal of Assets It was resolved to agree to the recommendations of the Finance and Administration Committee regarding the sale and disposal of assets.
- 13/111B **Items to Report from Grounds Maintenance Officers**

- 13/111.1B <u>Bridge Green (The Copse)</u> It was **resolved** to note that the stones would be placed shortly. It was advised that dog litter was a problem and it was hoped the situation would improve when the grass was shorter.
- 13/111.2B <u>Bellamy's Corner</u> There was nothing to report, however good feedback had been received regarding the bulbs which were now coming through.
- 13/111.3B <u>Doniford Car Park</u> It was **resolved** to note that more holes had appeared after the recent bad weather. It was **resolved** to wait until the weather had improved before making any repairs.
- 13/111.4B Recreation Ground and Play Area It was **resolved** to note that more vandalism had occurred in the story telling area of the playground. The Clerk would arrange the repairs.
- 13/111.5B Street Furniture It was resolved not to move the litter bin from the hospital as it was well used.
- 13/111.6B Grass verges There was nothing to report.

## 13/112B Overgrown Vegetation on steps of Limpetshell Lane

The Clerk advised that she had contacted Magna and the Highways to find out ownership but had no success. It was suggested that she contacted the District Council for advice. Cllr Troman also agreed to look into the ownership.

## 13/113B Dog Litter Bins

Cllr Troman asked the Council to consider purchasing two dog bins, one by the hospital and one at the bottom of Watchet Hill, as she had received several requests for these from local residents. Due to high maintenance costs it was suggested first looking at possible relocations of bins that were not being well used and the Clerk agreed to write to the District Council for details of use of all the bins in Williton including the bin at the top of Watchet Hill which was over the boundary in Watchet. She would also ask if they would be willing to provide any more bins.
