After a Proposal by Cllr Peeks and Seconded by Cllr McDonald, it was unanimously **resolved** to approve the minutes.

14/109B Matters to Report

14/109.1B (Item 14/89.1B) <u>Pedestrian Routes</u> It was **resolved** to note an email had been received in February 2014 from Alex Johnston, of which he was still awaiting a reply. Responses were made from Councillors present and it was **resolved** the Clerk would reply and report back to next meeting.

14/109.2B (Item 14/89.2B) <u>State of Road at St Peter's Close</u> It was **resolved** to note a reply was still awaited from Property Services.

14/109.3B (Item 14/89.3B) <u>Village Information Board</u> It was **resolved** to note no further information was available and Cllr McDonald was still researching the matter.

14/109.4B (Item 14/89.4B) State of Market Ground & the Hole in Bank Street It was **resolved** to note the hole in Bank Street had been filled and Mr Gliddon had been Thanked. It was **unanimously resolved** to remove this item from the agenda.

14/109.5B (Item 14/89.5B) Flooding Matters It was **resolved** to note the full report taken to the February Full Council meeting. Cllr McDonald reported the next meeting with West Somerset Flood Group was to be held on 13th February. Cllr McDonald and Cllr Bigwood would be clearing the stretch by the Paddocks on 12th

February, after which it was **resolved** to note that all streams had been cleared as far as Doniford. Cllr Koch thanked Cllr McDonald, working groups and all that had been involved for carrying out this important

Newman was establishing whether they were still in situation and still suitable for use.

No further communication had been received from Sarah Littler and it was **resolved** the Clerk would contact her for an update. It was also **resolved** the Clerk would contact Paul Conibeare from West Somerset Railway and request a meeting at the Parish Office to discuss the project and to confirm the Parish are happy to facilitate getting parties together, but that they believe the West Somerset Railway

should take the lead regarding funding applications.

It was **resolved** the Clerk would contact Magna to request the fence be re-installed by the steps on Union Lane, where Whitecroft joins Long Lakes.
