## 13/08 Approval of the Minutes of the Meeting held on 6th April 2013

It was unanimously **resolved** to approve the minutes.

#### 13/09 Matters Arising from the Minutes

13/09.1 (Item 12/229.1) <u>Hinkley C Consultation</u> It was **resolved** to note the report from the EDF Transport Forum meeting held on 19<sup>th</sup> April and that the roundabout was part of Phase 2 and would only be built if EDF reached agreement of electricity prices with the Government

### 13/10 Report from Avon and Somerset Constabulary

PCSO Thompson gave the crime figures for the last month. She advised that they were keeping an eye out regarding the badger cull and pointed but that there were now only 2 Beat Managers for the whole area and one PCSO position had been lost.

### 13/11 Report from Somerset County Councillor

Cllr Davies was congratulated on his recent appointment and welcomed to the meeting in his new role. He advised there was little to report at this stage as he was undergoing a series of training sessions.

#### 13/12 Report from West Somerset District Councillors

Cllr May advised that he had attended the recent funeral of Peter Lacey which had been extremely well attended. He had recently carried out another "walkabout" exercise with the Highways Department and advised that work to the pedestrian crossing would start shortly. He advised that the road outside Danesfield would not be surfaced in the near future and Doniford Rd had been patched and dressed. Work at Mamsey Bridge was in hand and the drains in Robert Street were partly complete. Wyndham Estate had asked the farmer to clear out the river behind the school. The street lights in Long Street continued to cause a problem for the electricity board. He thanked the Chairman for his work on highways and other matters during the past year.

#### 13/14 Correspondence

- 13/14.1 It was **resolved** to note the contents of the correspondence log.
- 13/14.2 It was **resolved** to accept the offer from Somerset Skills and Learning to do a brief presentation on Neighbourhood Learning in Deprived Communities and to invite to a future meeting.
- 13/14.3 It was **resolved** to note details of the A39 Diversionary Signage Scheme from Somerset County Council.
- 13/15 Report from the Environment and Planning Committee held on 8th April 2013
  It was resolved to note the report.
- 13/16 Report from the Finance and Administration Committee held on 15th April 2013 It was resolved to note the report.
- 13/16.1 (Item 12/98.1A) It was **resolved** to agree recommendations to keep the charges for the Parish Office the same as last year after a proposition by Cllr Woods seconded by Cllr Koch.
- 13/16.2 (Item 12/99.2A) It was **resolved** to note the provisions as at 1<sup>st</sup> April 2013.
- 13/16.3 (Item 12/104A) It was **resolved** to purchase a new speed detection device and two clickers provided that a second hand device could not be purchased. Cllr Woods agreed to look into this.
- 13/16.4 (Item 12/1052A) After some discussion and questions asked to the representatives of the Williton Rifle Club who had explained their project plans before the meeting, a proposition was put forward by Cllr Woods and seconded by Cllr Peeks to support their application for \$106 funding to improve their facilities up to a maximum of £5000. An amendment was put forward by Cllr Beaver seconded by Cllr Troman to support the application with no financial limit. This amendment was not carried (2 in favour 6 against) and the first resolution was put forward again and carried with 7 in favour and 2 against. The Clerk was asked to write to the Williton Rifle Club advising them of the decision and suggesting they advertised their club in Williton Window.
- 13/16.5 (Item 12/107A) This matter would be dealt with at the end of the meeting in Committee at item 13/26
- 13/16.6 (Item 12/108A) This matter would be deferred due to the prospective long term sick leave of the Groundsman.
- 13/16.7 Cllr Vaughan had requested a valuation of the area of land owned by the Community Hall charity for insurance purposes only and had not anticipated any costs arising from this.
- 13/16.8 It was **resolved** to pay £180 from the Tourism budget towards the cost of the Play Scheme at the Village Fete. There was a query regarding the interest on the grant set aside for the charity and it was **resolved** to put this forward to the next Finance and Administration Committee.
- 13/17 To receive accounts for payment not covered by Finance and Admin Committee

  There were none.
- 13/18 Report from Williton Regeneration Forum held on 1<sup>st</sup> May 2013

Cllr Woods had circulated a brief report and added that the meeting had been positive than previously. Suggestions had been made for the Parish Council to look at ways to encourage pride in the village and it was **resolved** to put this item on the Environment and Planning Committee agenda.

13/19 Report of Parish Plan Meeting held on 10<sup>th</sup> April 2013

It was **resolved** to note the report and that it was proposed doing a leaflet drop provided there was enough support. A further meeting was scheduled on 22<sup>nd</sup> May to discuss the future of the Plan and the funding.

- 13/20 Report from the West Somerset Voluntary Sector Forum held on 17<sup>th</sup> April 2013
  - As Cllr Beaver was unable to attend this meeting she suggested waiting for the minutes to be circulated.
- 13/21 Flooding Matters and Report from Exmoor Society's Spring Conference held on 26<sup>th</sup> April 2013 It was **resolved** to note the report.
- 13/22 Report from Archie Steering Group meeting held on 23<sup>rd</sup> April 2013

It was **resolved** to note the report and that the signage had to be put inside of the fencing due to planning regulations.

## 13/23 Report of Williton Community Hall Joint Working Group held on 23<sup>rd</sup> April 2013

It was **resolved** to note the report and that 80% of the responses to the survey had demonstrated the need to replace the changing rooms with a new building with unanimous agreement to improving the footpath. A meeting was scheduled to take place on 14<sup>th</sup> May to look at the results in more detail and specifically at the individual comments that were made. The group would look at the implications at merging the two charities as suggested at the Parish Assembly.

#### 13/24 Matters to Report from Parish Assembly

A proposition had been put forward at the Parish Assembly to consider merging the Williton War Memorial Ground and Williton Community Hall charities. This matter would be placed on both the charities agendas and the Finance and Administration Committee would look at the implications regarding finance and budgets. Care would need to be taken that the objects of both charities were not compromised.

### 13/25 It was resolved to exclude the press and public from the remainder of the meeting

### 13/26 Devolvement of Services – to appoint contractor for Somerset County Council land

It was **resolved** unanimously to appoint West Somerset Council to cut the County Council grass areas 12 times per year after a proposition by Cllr James, seconded by Cllr Woods. They would also be asked to include the area at Casino Road. It was further **resolved** to appoint West Somerset Council to carry out the weed spraying twice a year after a proposition by Cllr Vaughan seconded by Cllr Beaver.

# 13/27 Report of meeting to discuss the future planning of Williton held on 2<sup>nd</sup> May

It was advised that this meeting was well attended and extremely positive with landowners and key District Council officers taking the opportunity to meet together to discuss potential planning matters. A further meeting would be arranged looking at alternative plans which would include a Relief Road.

# 13/28 Proposed land acquisition from Doctors' Surgery

It was **resolved** to note the letter from the Practice Manager and to look at the proposal to widen the vehicle access route to include a public footpath. Cllr Vaughan had requested an estimate for the cost of moving the electricity pole. It was **resolved** to ask the Working Group to investigate further ideas with the Doctors.
