16/147B Matters from the Minutes – for the purpose of report only

16/147.1B (Item 16/131.1B) <u>Street Art in the Tractor Shed</u> Cllr Hooper had indicated she would be happy for the Street Art boards to be stored in the container used by the Church, if there was sufficient room. Mrs Copp

had been contacted to discuss further.

16/147.2B (Item 16/131.2B) <u>Steps between Union Lane and Long Lakes</u> It was **resolved** to ask Wyndham Estate for

a copy of their boundary to enable comparison with Magna boundary to try and ascertain the ownership of

the strip of land by the steps.

16/148.1B A letter of complaint had been received from Mr P Roche regarding the cigarette ends causing rubbish

outside the Wyndham Arms Public House. It was unanimously resolved to write to the Wyndham Arms to

request the installation of a disposal unit be fixed to their wall.

16/149B Highway Matters

16/149.1B An email had been received from County Roads regarding Dovetons Flats, Long Street requesting

ownership information. It was **resolved** to reply stating the Parish Council did not know the owner, but would advise if new information came to light. It was further **resolved** to request a date when the hedge

would be pruned due to the obstruction being caused.

16/151B Items to Report from Grounds Maintenance Officers

16/151.1B Bridge Green (The Copse) Cllr McDonald had met with Richard Wedgewood, Wyndham Estate, who

confirmed their reluctance to place stones around the copse due to any future potential development at Bridge Farm. The parking issues had been discussed at Parish Council regarding access concern for emergency vehicles, the Clerk confirmed a letter had already been sent to Highways. After a proposal from Cllr Peeks, it was **resolved** to write to West Somerset Council and Somerset County Council

advising them of the parking issue as it was believed some of the cars may belong to their employees.

16/151.2B Bellamy's Corner There was nothing to report.

16/151.3B Doniford Car Park Due to the recent resignation of Cllr White, it was unanimously **resolved** Cllr Birkett would become the responsible officer for the reporting of Doniford car park. The 'Danger, Crumbling Cliff' signs had arrived and would be erected when the new fence was in place, work was due to commence mid-February 2017.

16/151.4B Play Equipment in Recreation Ground It was **resolved** Cllrs McDonald and Peeks would advise on the report from The Play Inspection at the next meeting.

16/151.5B Street Furniture Cllr Peeks reported the Leylandii hedge between the playpark and Bowling Club had overgrown the bench. It was **resolved** the Clerk would investigate who the hedge ownership and if it belonged to the Bowling club to request that it be cut-back.

16/151.6B Grass verges There was nothing to report.

The flood shed had been erected; Cllr McDonald thanked Garry Austin-Thompson for his assistance. It was **resolved** to note that shelving and head torches were still needed. The flood equipment would be moved into place. The Clerk would ask Cllr Richards regarding the supply of sand bags. Cllr Denton expressed concern regarding the ditch by number 1 Highbridge that had become overgrown and a possible flood issue. It was unanimously **resolved** the Clerk would contact Highways to request the area is cleared as they had maintained this area in the past.
