As Cllr McDonald was in attendance, he duly signed the Declaration of Acceptance, after which he was able to take part in the remainder of the meeting.

20/10 To consider and agree Insurance Renewal

A discussion took place where three quotations were considered. After a proposal from Cllr Peeks, seconded by Cllr Howes, it was unanimously **resolved** to renew with the current provider, Zurich Insurance for a further two-year term.

20/11 It was resolved to note the update on the current position following Government guidelines that Parish Councils are unable to physically meet due to the current Covid 19 pandemic, until May 2021 or until the Government advises they would be permissible once again.
