## Comments:

A discussion took place where each Councillor gave their views on the application; the main points raised were:

- Effect on appearance of surrounding landscape
- Accumulative effect with Bye Farm
- Effect of users and enjoyment of Rights of Way
- · Loss of grade 2 and 3a Agriculture land
- Loss of employment
- Adverse impact on tourism and potential loss of tourist spending in this area
- Adverse effects on local listed buildings, St Decumans Church, Kentsford Farm, Barns at Washford and Tropiquaria
- Lack of information access visibility splays, no design of buildings
- No justification as to why this site had been chosen
- Close proximity to Hinkley Point
- Concern regarding ecology and environment

After a proposal from Cllr Hooper, seconded by Cllr Nye, it was unanimously **resolved** to object to the application based on the observations above. A response would be formulated to include legislation and forwarded to Somerset West and Taunton Council.

It was further resolved a copy of the objection would be displayed in the Parish office window and published on the Parish Council website.
